1. Apologies

- a. Apologies received by the Secretary: Alex Christie
- b. Apologies received from the floor: nil.

2. Minutes of the previous Annual General Meeting

a. Motion to accept the minutes from the previous Annual General Meeting as a true and accurate reflection of the meeting.

3. Business arising from previous minutes

a. Nil.

4. Correspondence

- a. David Selvey reported on ECA updates:
 - i. Regular season commencement Oct 1st
 - ii. T20 Team of the Season Comp: MacGibbon vs Dunstan: 1 game on turf (Wed 23rd Nov), and 1 on Synthetic (Wed 1st Feb). And extend this to Wright vs. Burt
 - iii. Endorse and commit to, and sign the "Safeguarding Children and MPP Declaration" for Season 22/23
 - iv. Switching from MyCricket to PlayerHQ the following season 23/24 (not this upcoming one), including all teams doing electronic scoring.
- b. Andrew Hind: Richard Barker has resigned as ECA President. Best wishes to the incoming ECA president. Some minor rule changes voted on at the ECA AGM: The over rate improvement rules did not get up.

5. Secretary's report on previous season

a. David Selvey reported that the Club paid \$180 total in association fines:

i. Seniors fines: \$140ii. Juniors Fines: \$40

6. Endorsement of latest Child Safety Policy from Cricket Australia

- a. New Cricket Australia Policy Documents: To be reviewed, discussed and endorsed by the Club.
- b. New policy documents and signed declaration to be uploaded and promoted
- c. Appointing of a Child Safety Officer (Section 9 below)

7. Treasurer's report on previous season

- a. Cal Jackson presented the financial statements as attached in Appendix 2, and made the following comments:
 - i. Overall we are in \sim \$5000 loss;
 - o With seniors in profit of \$10k
 - o And juniors in loss of \$15k (due to \$36k spent on uniforms)
 - ii. Gross margin on the bar was down: shall aim to get this back up.
 - o Trying to find someone to act as barman (paid).
 - o A shout out to David Hook for keeping the bar stocked.
 - iii. The Club received significant money from Sponsors and Grants A shoutout to Jack Graves for all the hard work. This allowed The Club to buy some of the needed equipment, including upcoming spends on BBQ and iPads.
 - iv. The Club is in a generally strong financial position going forward.
 - v. Update on Subs & player memberships upcoming: 1 combined payment (see Section 11 below)
- b. Questions from the floor:
 - i. David Hook: On 1 combined payment: How will this work if I want to play a few (2 or 3) games when in Melbourne. Cal response: Probably a pro rata or equivalent this will need to be looked at.
 - ii. Sam Jordan: Positive feedback on the single upfront payment. With CPI increases, how will the club recoup costs or maintain a good financial position? Response from Cal: The modelling suggests that the upfront payment will address this. Additionally, junior fees are going up to account for increases in ground hire costs, etc.
 - iii. Peter Cutter: iPad Costs: Is this for new iPads? Exec response: Yes.
 - iv. Tim McKenna: Is there any discount for paying upfront, and committing to a full season? Response from Cal: We will investigate this, and see if the modelling can support it (it might mean an increase if you don't pay upfront)

 - iii. thanked Sammy J for his service as captain of the 4th XI.

11. General Business

a. Andrew Hind: Thankyou's and welcomes:

- i. Reiterate the thankyou to Mel Norquay for her service as Juniors Vice President. Tremendous work over many years. And welcome to Claire as the incoming vice president.
- ii. Reiterate the thankyou to David Hook for his service as Social Secretary. Great work. And welcome to Nick Sparks for taking on this role.
- iii. A thankyou to Kane: for his new role as Chairman of Selectors, and
- iv. A thankyou and congratulations to Anthoni Suresh for being named 5th XI Captain.
- b. Andrew Hind: Other updates:
 - i. On New Pavilion: Expecting a Design review next week. Progress is slow but happening.
 - ii. Club room Handover timing to be advised: We will organise a club clean (and transfer of equipment) once we get the keys.
- c. Questions / Comments from the floor:
 - i. Tim McKenna: Where will the teams' grading finish up? Response from the Exec: ECA has advised us that the E-grade competition will end (lack of teams) so our Club teams may find themselves moving up or holding their grade. This is largely up to the ECA so we will have to see where this finishes up. Our preference is to keep our 2's in Burt.
 - ii. Comment from John G: With our 5th XI now in D-Grade, our preference is to keep this to 60 overs.
 - iii. Peter Cutter: Will Chris H continue the food supply? This received positive feedback Exec response: Yes.

12. Player memberships and levies for forthcoming season

- a. Cal Jackson advised the meeting that:
 - i. player membership fees & weekly match fees will be combined to 1 upfront payment as follows
 - o \$310 for students/unemployed members;
 - \$420 for employed members. (replacing the previous \$220 membership + \$15 weekly fee)
 - o Juniors will continue to pay weekly match fees
 - O As reflected in previous questions/comments: this will need to be looked at to see if an upfront discount can be provided

13. Date and place of pre-season training

 - i. Pre-season at Citipower Centre, Junction Oval. Commencing 17th Aug
 9pm 10pm. A total of x6 1hr sessions. This will be extended to 5 lanes for the upcoming session.
 - ii. Additional pre-season preparation

 - o Sun: IntraClub match practice to be organised
 - Spoke generally about on-field preparations for the forthcoming season.
